ATTENTION TAX SALE INTERESTED PARTIES: Recently enacted legislation(HF256), effective for June 2009 Tax Sale, requires “to be authorized to register to bid or to bid at tax sale or to own a tax sale certificate, a person, other than an individual, must have a federal tax ID# and either a designation of agent for service of process on file with the Secretary of State of Iowa or a verified statement meeting the requirements of chapter 547 on file with the county Recorder of the county in which the person wishes to register to bid or to bid at tax sale or of the county where the property that is subject of the tax sale certificate is located.
