Ball was present for the monthly RUSS and SEI Link meetings. Ball was also emailing the City of Letts about Letters of Support for grants to help them get rundown buildings cleaned up.

Larry Roehl and Adam Shutt gave the weekly Secondary Roads update. The Board spoke to Roehl about the possibility of signage at Fredonia and at other places in the County. Also discussed were the fuel tanks at Oakville, Grandview and Columbus Jct. and if it was efficient to use the tanks vs the liability or if the County should contract out the fuel.
